Thank you for your request dated 14 March 2024.

We can confirm that the ICB does hold the information you requested.

Please find our response to your questions below:

Information on the median length of time from referral to assessment is not held by the ICB, this would need to be sought from the children's autism assessment providers:

- d. East Lancashire Hospitals Trust
- e. Lancashire Teaching Hospitals
- f. Blackpool Teaching Hospitals

7. What support and further referral is routinely offered to children who receive an autism diagnosis through Lancashire and South Cumbria ICS.

The ICB is undertaking a piece of work to redesign the pathway which will include mapping and development of a consistent offer of support for children with neurodevelopmental needs including autism. Currently pathway navigators within each of the providers share information with families regarding the support available following a diagnosis. This may include cygnet training and workshops. Information is also accessible on the local offer websites for each of the local authorities. There is not a single, published offer across Lancashire and South Cumbria at this time.

- 8. What support and further referral is routinely offered to adults in who receive an autism diagnosis through Lancashire and South Cumbria ICS.
  - In Lancashire and South Cumbria, an online offer is provided through Autism Unlocked.
- 9. What support and further referral is routinely offered to children who undergo an assessment for autism through Lancashire and South Cumbria ICS but do not receive a diagnosis.
  - The ICB is undertaking a piece of work to redesign the pathway which will include mapping and development of a consistent offer of support for children with neurodevelopmental needs including autism. Currently pathway navigators within each of the providers share information with families regarding the support available whilst on the assessment pathway which may include local services and peer support. There is an online support offer available across Lancashire and South Cumbria via the website Autism Unlocked.
- 10. What support and further referral is routinely offered to adults who undergo an assessment for autism through Lancashire and South Cumbria ICS but do not receive a diagnosis.
  - Adults who do not receive a diagnosis are still directed to Autism Unlocked as a resource and area for information.
- 11. What standardised tools are currently used in Lancashire and South Cumbria for the screening and/or triage of children who seek an autism assessment.
  - The work to design a new neurodevelopmental pathway will include the recommendation of a consistent set of tools and approaches for screening and triaging children and young people referred for an autism assessment to ensure compliance with the NICE guidance. The providers would be able to provider further detail on the specific tools used.
- 12. What standardised tools are currently used in Lancashire and South Cumbria for the screening and/or triage of adults who seek an autism assessment.

Both ADOS and ADI-R are used.
