Each MAS service achieved the 70% target of service users being seen within 6 weeks target. There is some variance across the MAS teams in the KPIs due to staffing levels and sickness. However, ongoing work is taking place to address this, and commissioners are monitoring the improvement in achieving the KPIs

9. What is the length of your current memory assessment contract(s) and when is it(they) up for renewal?

The memory assessment contract is part of the block contract with Lancashire Care Foundation Trust

10. What are your priorities for memory assessment in the next 3 years?

The priorities for the next years are to increase the % of people receiving a dementia diagnosis and consistently achieving all the KPIs in place for this service.
