We can confirm that the ICB does hold the information you requested.

Please find our response to your questions below:

1. Does the ICS / former CCGs offer a locally enhanced service incentive scheme (e.g. for the management of long term conditions, targeting of specific patient cohorts or admission avoidance) to your GP practices, or has a scheme of this nature been offered in the last 5 years?

The former CCGs had numerous Local Enhanced Services/General Practice Quality Contract schemes that the ICB has recently reviewed and proposed some changed arrangements, further details of which can be found in a recent public Primary Care Commissioning Committee paper.

Within the March meeting the agenda for Local Enhanced Services was covered. A link to the papers is included below
