3. Planned arrangements for providers found to be in breach of the contract specification to provide 11% of cataract operations as wholly delivered by NHS ophthalmic trainees within 2 years.

We are currently assured that the independent providers with signed contracts to deliver cataracts are engaged with the relevant deanery to engage trainees. These providers will rely on the deanery scheduling trainees with them to enable training to take place. The ICB will continue to engage with providers to support the intended training requirements, where the deanery supports.
