Thank you for your request dated 9 April 2024.

We can confirm that the ICB does hold the information you requested.

Please find our response to your questions below:

I am part of the set up and planning team from Barnardo's newly commissioned Children's and Young people Thrive Mental Health Services for Lancashire & S. Cumbria ICB.

I am wondering if you could direct me to the correct department/person that I can connect with regarding obtaining a current ICB-wide GP Surgery directory and information and/or a map showing the details of the ICB's boundary locations.

A list of GP practices within the Lancashire and South Cumbria area is available via the following link: [Patients Registered at a GP Practice, March 2024 - NHS England Digital](#). This can be obtained via the following method - with a practice --> PCN --> Sub-ICB --> ICB level hierarchy (that may assist with service planning) - is via the monthly registered population updates released nationally (March 24).

There is a mapping file which can be filtered to show the 197 practices in Lancashire and South Cumbria ICB (though a subset of this file is attached). In addition, there are other datasets and an interactive dashboard which can be used to explore further (with some limited mapping functionality)

If you want to get full address details etc and GPs aligned to practices then a useful resource is available at this link: [NHS Digital ODS Portal](#). From here you can access the full national hierarchy of organisations and addresses, etc. The link will direct you to the relevant ICB, in which you can then click into the 'Clinical Commissioning Group' drop down menu, and by selecting one of the CCGs you will get a list of the Primary Care Networks (PCNs). Once you click into the relevant PCN you will then receive a list of practices (they can be found under the prescribing cost centres link) and from this you can obtain addresses.

This link from NHS England may also assist - [NHS England » Integrated care in your area](#). This offers the nationwide position, has details as to which areas are covered and has a map which

may be of use.
