Thank you for your request dated 5 April 2024 and clarification received on 16 Aril 2024.

We can confirm that the ICB does hold the information you requested.

Please find our response to your questions below:

On what date were you made aware that Craig Harris previously had a close working relationship with Dr Shikha Pitalia of SSP Health (during his time as Managing Director of the Healthier Wigan Partnership)? I believe it was the 22nd of February 2023 when Kevin Lavery, seemingly surprised, asked a steering group member to email him the proof of this after said group member challenged him on it at one of their meetings by showing him a photograph of Mr Harris and Dr Pitalia together at an SSP Health event (held on the 26th of September 2019).

The section of the minutes is requested from 22 February 2023 and the steering group was, Withnell health centre steering group, obviously the date "he became aware" isn't held information unless he has that written down somewhere specifically, so we'd be clear we can only provide a copy of that section of the minutes.

Mr Lavery had been made aware prior to 22 February 2023 that Dr Pitalia was known to Professor Harris in a professional capacity. SSP Heath were awarded a contract to provide primary care services on behalf of the Healthier Wigan Partnership of which Professor Harris was Managing Director. Both Dr Pitalia and Professor Harris were members of the Healthier Wigan Partnership Board. There is no conflict of interest.
