Please find our response to your questions below:

1. ARRS budget utilisation in Primary Care Networks (PCNs):

We'd be most interested in data with:

- ODS Code of PCN
- ARRS total spend/utilisation for 2023/24 & if available 24/25. i.e. How much a PCN spent of their allocated budget.
- If there is breakdown on what the roles were (Pharmacists/Physician Associates?)

£43.106m for 2023/24.

The allocation for 2024/25 is £44,968m based on the guidance of £22.894 x PCN Q4 2023/24 Weighted List. There is not any overspend as activity is not yet known.

Please note that the allocation and the utilisation for ARRS are the same. The ICB spends up to its allocation. ARRS has an initial allocation at the start of the year and then towards the end of the year we submit a Forecast Outturn position, and a further allocation is provided to cover 2023/24 spend. The full allocation was spent for 2023/24.
