Thank you for your request dated 10 June 2024.

We can confirm that the ICB does hold the information you requested.

Please find our response to your questions below:

Due to the recent announcement by NHS England, that asks integrated care boards (ICBs) to "establish and develop at least one women's health hub in every ICB by the end of December 2024 in line with the core specification, improving access, experience and quality of care" and sets the expectation that at least 75% of ICBs have a hub in place by July 2024 that meets minimum requirements. https://www.england.nhs.uk/wp-content/uploads/2024/03/2024-25-priorities-and-operational-planning-guidance-v1.1.pdf

1. I wanted to find out if your ICB had launched your women's health hub as of yet?

Not at present.

Please note, we are currently undertaking a data analysis on the needs of the ICB and service mapping what we have:

- We have a steering group that has been stood up that meets every 2 months, which commenced in May. The aim is to drive this programme of work forward.
- We currently do not know how many hubs we will have, as the new guidance released in April 2024 has changed the requirements making it more challenging to open multiple hubs at once.
- o The money is being used for Project costs.
- We are working on an ICB wide approach, so we are also trying to improve the 8 core services across general practice, in addition to hub work, so care should improve overall going forward.
- We are running an event for providers/HCP/commissioners/VSCE on 12 September, where we will release the next main update from the programme. This is not for patients however. We are also planning a communications piece soon.

2. If not, when this is due to open?

To be confirmed - We aim to have 1 hub open by December 2024 as a minimum.

3. Can you confirm the name of your clinical lead for the Hub?

We do not have a confirmed hub location at present, Therefore, this post has not been recruited to.

4. Please confirm a contact email address for the hub plus postal address for that actual site?

We do not have a hub location confirmed at present.
