#### **Executive summary**

As members will recollect the GPQC proposal for 2024/25 was presented to committee in March 2024 and included an outline of the three service areas, the associated financial payments and payment methodology.

The paper detailed the investment, return on investment and number of reviews for each of the three services as per the table below:

Funding for practices has been made through 12 equal payments of 80% of their contract value with the remaining 20% to be paid following an annual reconciliation undertaken in April/May 2025.

Practices are now in month 9 of this year's GPQC. The enclosed analysis provides an overview of the current delivery across each ICB place between April and November 2024. Delivery across Lancashire and South Cumbria shows steady progress:

The percentage of practices delivering over 50% of their individual practice targets:

- Structured Medication Reviews (SMR) = 72.73%
- Frailty bundle 1 = 60.84%
- Frailty bundle 3 = 31.12%

Delivery has significantly increased between October and November 2024 with has with percentage increases of:

- SMR = 20.90%
- Frailty bundle 1 = 26.54%
- Frailty bundle 3 = 46.61%

It is anticipated that achievement will continue to increase up to the end of March 2024. Due to this being a new contract there is no historical data to enable a comparison of previous years achievement.

Delivery dashboards have been shared with each primary care place team to support a midpoint health check of practice delivery of their individual targets. Each practice has received an individualised letter with a tracker of their current delivery. Practices identified with low or high delivery have also been highlighted to place teams, along with a support prompt to guide additional discussions. Additionally, the Local Medical Committee has held place sessions to share good practice

The paper presented to committee in March 2024 also outlined that an assessment of achievement would be undertaken in January 2025 and any under delivery offered out to other practices.

## Summary of GP Practice achievement against Frailty Targets – 1<sup>st</sup> April to November 2024

• This slide illustrates GP practice delivery of Frailty targets from April to November 2024, highlighting a strong achievement in Bundle 1 Assessments, where 25% of practices have exceeded 100% of targets. Bundle 3 MDT targets show lower delivery, with a large number of practices (49.49%) achieving only 0-25%.

### Summary of GP Practice achievement SMR Targets - 1st April to November 2024

• The slide summarises GP practice delivery of SMR targets from April to October 2024. It shows that most practices (36%) are achieving within the 51-75% range, followed by 24% in the 26-50% range. Only a small portion of practices are meeting or exceeding 100% of the target (10.71%), while 3% are in the lowest achievement bracket (0-25%).

# Combined summary of GP Practice achievement for Frailty and SMR targets 1<sup>st</sup> April to November 2024

• This slide provides an overall summary of GP practice delivery of Frailty and SMR targets from April to November 2024. It shows that 24% of practices achieved in the 0-25% range, 21% in the 26-50% range, and 24% in the 51-75% range. A smaller proportion of practices reached higher achievement levels, with 16.33% achieving 76-100% and 14.97% exceeding 100% of targets. It is anticipated that achievement will continue to increase up to the end of March 2025. Typically practices deliver these types of enhanced services in the latter two quarters of the financial year.

## Place & LSC percentages of improvement per specification ranging September - October BI Data

- This slide outlines the monthly percentage increases in GP practice delivery across Lancashire and South Cumbria for SMR activity and Frailty Bundles 1 and 3 between September and October 2024:
  - SMR Activity: The system saw an average increase of 20.90% in SMR activity, ranging from 15.26% in Blackburn with Darwen to 25.74% in Chorley and South Ribble.
  - Frailty Bundle 1: Frailty Bundle 1 activity improved by an average of 26.54%, with the largest increase in Fylde and Wyre (39.07%).
  - Frailty Bundle 3: Frailty Bundle 3 recorded the highest average improvement at 46.61%, with significant growth in Blackpool (60.92%).

The data highlights consistent progress across all areas.
