Q1	<p>Your Question:</p> <p>Please could you kindly share (1) the name of the PCN(s) and relatedly (2) the name and email address of the PCN clinical director that the CCG(s) in your locality have been absorbed by.</p>																		
	<p>Our Response:</p> <p>Clinical Commissioning Groups have not been absorbed by Primary Care Networks.</p> <p>On 1 July 2022 clinical commissioning groups (CCGs) across the country closed and were replaced by new NHS organisations known as Integrated Care Boards (ICBs). NHS Morecambe Bay CCG no longer exists and has been replaced (along with the other seven CCGs in Lancashire and South Cumbria) by the new NHS Lancashire and South Cumbria Integrated Care Board.</p> <p>NHS Lancashire and South Cumbria ICB has 41 Primary Care Networks (PCNs), eight of these PCNs are within the Morecambe Bay area.
