Thank you for your request dated 4 April 2023

We can confirm that the ICB does not hold the information you requested.

Please find our response to your questions below:

Q1	<p>Your Question:</p> <p>Under the Freedom of Information Act, I would like to request the FOI email addresses for all of the sub-ICB locations (SICBLs) within the ICB. This is to address situations where data is not held by the ICB and so there is a need to request information at SICBL level rather than ICB level.</p> <p>To be clear, by SICBL I am referring to what was previously called 'CCGs' until 1 July 2022. By FOI email addresses, I am referring to the email addresses that each SICBL holds for people to send freedom of information requests to. For example, within Greater Manchester ICB there are ten separate email addresses for each of the SICBLs (former CCGs) e.g. Bolton - <a href="mailto:gmicb-Bol.foi@nhs.net">gmicb-Bol.foi@nhs.net</a>; Oldham - <a href="mailto:oldccg.foi.oldham@nhs.net">oldccg.foi.oldham@nhs.net</a>; Salford - <a href="mailto:gmicb-sal.foi@nhs.net">gmicb-sal.foi@nhs.net</a> etc.</p>
	<p>Our Response:</p> <p><b>All data requests have to be addressed to ICB level in normal way, we do not have any specific sub elements for data.</b></p>
