Executive summary

This report summarises engagement and involvement approaches with members of the public to support decision making for the Primary Care Commissioning Committee and its sub-groups.

Lancashire and South Cumbria ICB has agreed a Strategy for Working in Partnership with People and Communities which has been refreshed and agreed in August 2023. This has been developed with wide engagement and involvement with partners – including NHS, local authorities, Healthwatch, VCFSE and members of the public. This also aligns with national guidance for working in partnership with people and communities by NHS England which sets out the legislation for ICBs.

The communications and engagement team have reviewed the decision-making matrix for the Primary Care Commissioning Committee and this paper recommends an additional section which has been suggested based on examples of good practice, feedback from current engagement and alignment with the principles of the strategy for working in partnership with people and communities.

Group decision-making matrix – involvement and engagement

1. Introduction

- 1.1 Public engagement and involvement is an essential component of making sure that effective and efficient health and care services are provided to people and communities. By reaching, listening to, involving and empowering our people and communities, we can ensure that they are at the heart of decision making. The NHS in Lancashire and South Cumbria is committed to putting the needs, experiences, and insights at the heart of all we do.
- 1.2 Lancashire and South Cumbria ICB has agreed a Strategy for Working in Partnership with People and Communities which has been refreshed and agreed in August 2023. This has been developed with wide engagement and involvement with partners including NHS, local authorities, Healthwatch, VCFSE and members of the public. This also aligns with national guidance for working in partnership with people and communities by NHS England which sets out the legislation for ICBs. The strategy is available here: LSC Integrated Care Board:: Lancashire and South Cumbria strategy for working with people and communities (icb.nhs.uk)
- 1.3 Through the strategy, the ICB has set out 10 principles which will be aligned, adopted, adhered to and actioned in relation to engagement and involvement of members of the public, communities and partners. These align with national policy guidance on working in partnership with people and communities.

2. National Legislation

- 2.1 NHS England sets out the legal duties for ICBs in relation to public involvement and engagement in decision making. This is available in Section B1 (page 64) of the national Working in Partnership with People and Communities (england.nhs.uk) guidance.
- 2.2 The guidance states: The legal duties require arrangements to secure that people are 'involved'. This can be achieved by consulting people, providing people with information, or in other ways. This gives organisations a considerable degree of discretion as to how people are involved, subject to the below requirements. Neither the legal duties, nor this statutory guidance, seek to prescribe exactly how to involve people in any given case. Indeed, what is necessary will always depend upon the circumstances. Therefore, while this guidance is ambitious in its intent, it is not intended to place additional legal

obligations on organisations and does not mandate that organisations may only discharge their duties in a particular way. Statutory Guidance Public bodies are required to act rationally, and this applies to the arrangements they make to involve people. Public bodies can demonstrate that they are acting rationally by keeping good records of decisions taken about when and how to involve the public.

2.3 Based on the national guidance it is recommended that the following additions to the Primary Care Commissioning Committee decision-making matrix provide a basis for the expectations for engagement and involvement on any decisions which may be taken however the level, approach and purpose of the engagement would be determined following a detailed understanding of the context and circumstances relating to the decision.
