Executive summary

Haverthwaite Surgery in Backbarrow, South Cumbria, has contacted the ICB in respect of some issues with their existing premises. This paper provides a very high-level options appraisal. The practice has indicated their preferred option is to relocate to different premises and this paper seeks indicative ICB support to progress this option.

Haverthwaite Surgery Premises - High Level Options Appraisal

1. Purpose

- 1.1 The purpose of this paper is to inform the Committee of the current premises situation at Haverthwaite Surgery, to confirm ICB and practice responsibilities and to present a high-level options appraisal for consideration.
- 1.2 A full options appraisal including any associated interim measures, will be presented to the Committee in October.

2. Introduction

- 2.1 Haverthwaite Surgery (A82650) is a general practice (GP) holding a General Medical Services (GMS) contract located in Backbarrow, a small village near Ulverston. It is part of the Grange and Lakes Primary Care Network (PCN).
- 2.2 The practice is located in purpose-built premises, built in 1999. Though there are no quality or immediate safety concerns the premises are not currently at the standard that are expected for the delivery of primary medical services.
- 2.3 Under the GMS contract the contract holder is responsible for ensuring that the premises used for the provision of services under the contract are suitable for the delivery of services under the contract and sufficient to meet the reasonable needs of the contractor's patients. The minimum standards for practice premises is set out in schedule 2 of the National Health Service (General Medical Services Premises Costs) Directions.
- 2.4 The ICB has engaged in conversations with the practice to understand what their plan is in order to meet this contractual requirement.
- 2.5 The ICB is responsible for reimbursing the rent of primary medical services providers for any eligible space up to a value set by the District Valuer. The current rent that is reimbursed is £33,900 per annum. The level of rent is low reflecting the current state of repair of the premises. If the premises were brought up to standard the ICBs financial obligations would be in the region of £50,000 to £55,000 per annum.

3. Potential options

- 3.1 From conversations with the practice there are two potential options available:
 - Investment in the current premises
 - Relocation of the practice

3.2 Investment in the current premises:

- 3.2.1 Practices are able to apply to the ICB for an improvement grant which are funded through the limited capital budget the ICB receives.
- 3.2.2 To qualify for an improvement, grant a practice must have a signed lease in place with their landlord. Due to an historic dispute, there is no lease in place. It is unlikely that the dispute will be resolved without legal action being initiated by one of the parties.

3.3 Relocation of the practice

- 3.3.1 The proposal that the practice has presented to the ICB is for a relocation of the premises to an alternative site that is still within the village of Backbarrow.
- 3.3.2 The practice has secured a private landlord who is willing to develop a new premises in exchange for a 10–15-year lease.
- 3.3.3 There are no NHS capital costs associated with this option. The rental reimbursement rate is likely to be in region of £60,000 per annum.
- 3.3.4 The practice has requested indicative ICB support for a relocation to inform the development of a full business case to accompany an application for a relocation and any interim measures.

4. Conclusion

4.1 Haverthwaite surgery is currently in premises that does not meet the required contractual standards. The ICB have, therefore, sought assurances on how the practice proposes to meet these requirements. The practice has confirmed that they are seeking to relocate premises.

5. Recommendations

- 5.1 The committee is requested to:
 - 5.1.1 Note the current situation with regards to the premises used by Haverthwaite Surgery and the potential options the practice has to ensure it meets its' contractual obligations.
 - 5.1.2 Provide indicative support for a relocation as one of the options to secure premises for the delivery of primary medical services in Backbarrow.
 - 5.1.3 Note that the committee will receive a business case at the October meeting in respect of the practice's intent.
